### AGREEMENT REGARDING GOLF PRIVILEGES

THIS AGREEMENT REGARDING GOLF PRIVILEGES (this "Golf Agreement") is made as of the 2010 day of 2015 (the "Effective Date"), by TURTLE BAY RESORT, LLC, a Delaware limited liability company (hereinafter referred to as "TBR"), whose mailing address is 57-091 Kamehameha Highway, Kahuku, Hawai'i 96731, and the STATE OF HAWAI'I (the "State") by its Board of Land and Natural Resources, having an office at 1151 Punchbowl Street, Honolulu, Hawai'i 96813 ("BLNR").

#### RECITALS:

- A. TBR, the State, and the Trust for Public Land entered into that certain Purchase and Sale Agreement dated October \_\_\_, 2015 (the "PSA"), providing for the (1) conveyance of a conservation easement interest from TBR to the State (the "CE Transaction") over the real property described in Exhibit A and shown in Exhibit A-1 attached to the PSA (the "Phase I CE Property"), (2) granting of a right from TBR to the State to purchase a conservation easement (the "Phase II CE Option") over the real property described in Exhibit B and shown in Exhibit B-1 attached to the PSA (the "Phase II CE Property"), and (3) fee simple conveyance from TBR to the State (the "Fee Simple Transaction") of the real property described in Exhibit C and shown in Exhibit C-1 attached to the PSA (the "State Fee Simple Property"). The CE Transaction, the Phase II CE Option, and the Fee Simple Transaction are hereinafter collectively referred to as the "Transactions".
- B. The Phase I CE Property includes, among other things, the Fazio Golf Course and the Palmer Golf Course (collectively, the "Golf Courses"). The Fazio Golf Course is substantially located on Lots 7, 8, and 26 of the "Turtle Bay Bulk Lot Subdivision", as more particularly described in Exhibit A and as approximately shown on Exhibit A-1 attached hereto, and the Palmer Golf Course is substantially located on Lots 18, 21, and 25 of the "Turtle Bay Bulk Lot Subdivision", as more particularly described in Exhibit B and as approximately shown on Exhibit B-1 attached hereto. The Golf Courses shall be deemed to include any reconfiguration of the existing Golf Courses, and any future golf course built on the property described in Exhibit A and Exhibit B attached hereto.
- C. Pursuant Section 2.6 of the PSA, TBR agreed that it would provide certain privileges to use the Golf Courses to the golf team (the "<u>Team</u>") and coaching staff (the "<u>Staff</u>") of Kahuku High School, or successor high school ("<u>KHS</u>"). The KHS Team and Staff shall hereinafter collectively be referred to as "KHS Golf".
- D. This Agreement is intended to satisfy TBR's covenants in Paragraph 2.6 of the Purchase Agreement to provide to KHS Golf with certain designated playing privileges on the Golf Course.

#### AGREEMENT:

IN CONSIDERATION of the Recitals set forth hereinabove, which by this reference are incorporated herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, TBR and the State mutually covenant and agree as follows:

- 1. <u>Grant of Right to Use</u>. TBR grants to KHS Golf the right to use the Golf Courses, upon and subject to the terms and conditions set forth in this Agreement (the "<u>Use Rights</u>").
- 1.1 KHS Golf. Use Rights may only be exercised by individuals who are official Team members or Staff members as of the date of usage.
- 1.2 <u>Time of Use</u>. Use Rights may be exercised by KHS Golf only during the official Oahu Interscholastic Association golf season, and only during normal hours of operation of the Golf Courses.
  - 1.3 <u>Use Fee</u>. There shall be no fee payable for the Use Rights.
- 1.4 <u>Reservation</u>. Tee times for the Team must be reserved by the Staff no earlier than seven (7) days in advance, unless otherwise approved by the TBR's Director of Golf.
- 1.5 <u>Terms of Use</u>. At all times, KHS Golf shall comply with all standards, rules, regulations, guidelines, policies and procedures of TBR applicable to the Golf Courses. After each use of the Golf Courses, KHS Golf shall leave the Golf Courses in a clean and orderly condition.
- 2. Golf Carts. Upon request, golf carts will be provided at no charge to the Staff, subject to availability.
- 3. Permitted and Prohibited Uses of Golf Courses. KHS Golf shall use the Golf Courses only for practicing golf. KHS Golf shall not commit or allow to be committed any waste upon the Golf Courses, or any public or private nuisance or other act or thing which disturbs the quiet enjoyment of tenants, licensees, concessionaires, invitees, or hotel guests of the area(s) surrounding the Golf Courses. KHS Golf will comply with all laws and ordinances, and governmental rules and regulations applicable to the Golf Courses. KHS Golf shall be responsible for the acts or omissions of its invitees on or about the Golf Courses.
- 4. <u>No Representations Regarding Condition of Land</u>. TBR makes no representations, warranties or other assurances whatsoever as to, and shall have no liability with respect to, (i) the condition of the Golf Courses, or (ii) whether the Golf Courses shall continue to exist in their current size and configuration.
- 5. <u>Liens</u>. KHS Golf shall keep the Golf Courses and the land upon which the Golf Courses are located free from any lien, charge or encumbrance arising out of any act or negligence of KHS Golf, including, without limitation, any materials furnished by or for KHS Golf or obligation incurred by KHS Golf.

- 6. <u>Assumption of the Risk</u>. KHS Golf hereby assumes all risk of loss or damage to equipment and other personal property, stored or placed on or within the Golf Courses by KHS Golf, and does hereby agree that TBR shall not be liable for any loss, damage or liability of any kind, or for any injury to or death of any persons from any cause whatsoever, by reason of the use of the Golf Courses by KHS Golf or any person under KHS Golf.
- 7. Partial Release. If either or both of the Golf Courses, or portions thereof, cease to be operated as golf courses in the future, the parties hereto agree to execute and record a partial release of this Agreement releasing such portions from the terms of this Agreement. The release of this Agreement as above provided shall not operate to grant to the State or the KHS Golf any right to make any claim against TBR because of such release.
- 8. Assignment. TBR and the State acknowledge that the Use Rights granted by TBR to KHS Golf under this Agreement are specific and personal to KHS Golf as the golf team and coaching staff of the regional public high school, and the State agrees that it is strictly prohibited from assigning KHS Golf's rights under this Agreement; provided, however, that if KHS ceases to serve as the regional public high school, then such Use Rights granted under this Agreement may be assigned to the successor regional public high school's golf team and coaching staff.
- 9. Runs with the Land. The covenants, terms, conditions, and restrictions of this Memorandum shall be shall be deemed to run with the land.

#### 10. Miscellaneous.

- 10.1 <u>Further Assurances</u>. The State and TBR agree to execute and deliver such documents, and to take such other actions, as may be necessary to carry out the intent and purposes of this Agreement.
- 10.2 <u>Waiver</u>. Neither the failure nor any delay on the part of either TBR or the State to exercise any right or remedy under this Agreement shall operate as a waiver thereof, nor shall any single or partial exercise of any right or remedy preclude any other or further exercise of the same or of any other right or remedy, and no waiver of any right or remedy with respect to any occurrence shall be construed as a waiver of such right or remedy with respect to any other occurrence.
- Attorneys' Fees and Costs. If either TBR or the State reasonably retains counsel for the purpose of enforcing or preventing the breach of any provision of this Agreement, including, but not limited to, instituting any action or proceedings to enforce any provision hereof, for damages by reason of any alleged breach of any provision of this Agreement, for a declaration of such Party's rights or obligations hereunder, or for any other judicial remedy, the prevailing Party shall be entitled to all remedies now or hereafter existing at law or in equity.
- 10.4 No Real Property Interest Created. The State acknowledges and agrees that this Agreement is not intended to create or give rise to any interest in real property, or any right on the part of the State or KHS Golf to possession of any real property, and is merely a license.

- 10.6 <u>Parties in Interest</u>. This Agreement shall inure to the benefit of, and be binding upon, TBR and KHS Golf and their respective successors and assigns.
- 10.7 <u>No Third Party Beneficiaries</u>. Except as otherwise expressly stated in this Agreement, no term or provision of this Agreement is intended to be, or shall be, for the benefit of any person, firm, organization or corporation not a Party hereto, and no such other person, firm, organization or corporation shall have any right or cause of action hereunder.
- 10.8 <u>Neither Party Deemed Drafter</u>. TBR and the State each agree that it has been represented by counsel in connection with the negotiation and drafting of this Agreement, and that this Agreement shall be interpreted according to its fair construction and shall not be construed against either Party as the drafter hereof.
- 10.9 <u>No Partnership Intended or Created</u>. It is not intended by this Agreement to, and nothing contained in this Agreement shall, create any partnership, joint venture or other common enterprise between TBR, the State, and KHS Golf.
- 10.10 <u>Partial Invalidity</u>. If any provision of this Agreement or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remaining provisions hereof, or the application of such provision to persons or circumstances other than those as to which it is invalid or unenforceable, shall not be affected.
- 10.11 <u>Recordation of the Agreement</u>. This Agreement shall not be recorded, but both the State and TBR agree that a short form memorandum of this Agreement shall be recorded with the Bureau of Conveyances to give public record notice of this Agreement.
- 10.12 <u>Exhibits</u>. Each Exhibit referred to in this Agreement shall be deemed to be incorporated herein by the reference made to it, as fully and completely as though the entire Exhibit were set forth in the body of this Agreement.
- 10.13 <u>Amendments</u>. This Agreement shall not be modified except by a written instrument signed by TBR and the State. In the event that either TBR or the State requests an amendment to this Agreement, each Party shall be responsible for its own fees and costs.
- 10.14 <u>Titles and Headings</u>. Titles and headings to articles, paragraphs and subparagraphs herein are for the purpose of convenience and reference only, and shall in no way limit, define or otherwise affect the provisions of this Agreement.

- 10.15 Entire Agreement. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof, and replaces and supersedes any and all prior written or oral agreement(s) with respect to such subject matter.
- 10.16 <u>Governing Law</u>. This Agreement shall be governed by and construed and interpreted in accordance with the laws of the State of Hawaii.
- 10.17 <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall be deemed an original, and the counterparts taken together shall constitute one and the same instrument, binding upon TBR and the State, and notwithstanding that both TBR and the State are not signatory to the same counterparts. For all purposes, including, without limitation, recordation, filing and delivery of this Agreement, duplicate unexecuted and unacknowledged pages of the counterparts may be discarded and the remaining pages assembled as one document.

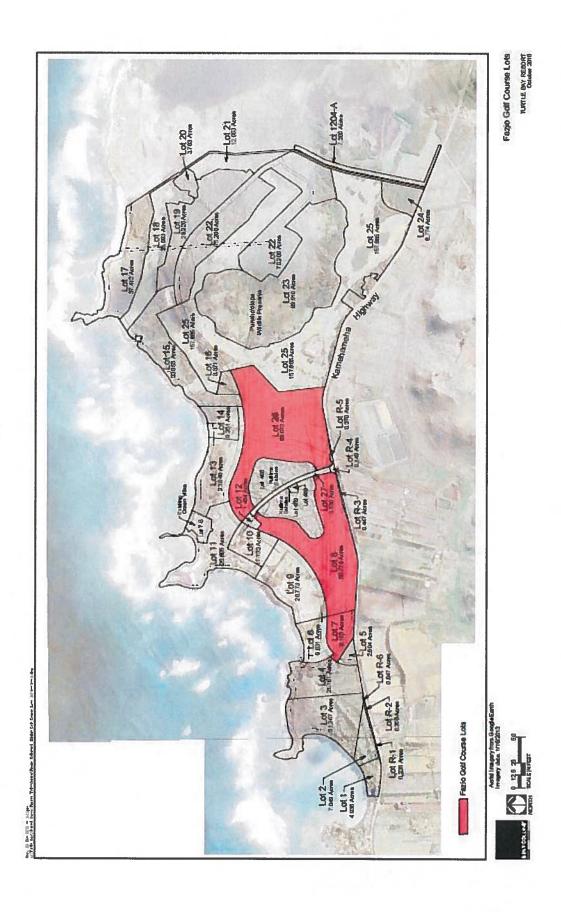
